Houston Chosen as Site for HIV Vaccine Clinical Trial

Houston has been selected as a site for the HIV Vaccine Trials Network (HVTN) 505 study. The Houston site is at the Baylor College of Medicine (BCM). BCM is trying to reach out in the GLBT community in Houston to raise awareness of the study as well as general HIV/AIDS education and prevention.

The study seeks gay and bisexual men between the ages of 18-45 to participate in the study, which is funded by the HVTN, under the National Institute of Health. The vaccine isn't preventative or curative, but is designed to help improve overall outcomes of men with HIV and reduce viral load if they do contract HIV. The study is also meant to help with understanding about the virus and with future vaccine development. The trial will be open for recruitment in the next few weeks.

"It's a big deal that Houston was given a HVTN study and we see it as setting a big precedent in the community here and the city of Houston with HIV/AIDS research and the search for a cure," said

Suicides draw attention to anti-bullying bills

from the Washington Blade

The widely reported suicides of four gay male teenagers in September that have been linked to school bullying or harassment has heightened interest in two separate bills in Congress aimed at curtailing anti-LGBT bullying and discrimination in the nation's public schools.

A third bill expected to be introduced next month by Sen. Frank Lautenberg (D-N.J.) would require colleges and universities to develop campus anti-bullying and anti-harassment policies that cover LGBT students.

"For those of us who work in education policy our focus is making the education case for these bills," said Eliza Byard, executive director of the Gay, Lesbian and Straight Education Network, known as GLSEN.

"And unfortunately we're doing that now in a context where recent tragedies have made the cost of not acting absolutely clear to everyone," Byard said.

"It's a big deal that Houston was given a HVTN study and we see it as setting a big precedent in the community here and the city of Houston with HIV/AIDS research and the search for a cure," said Maggie White, Research Coordinator.

Every 10 minutes, someone in the United States is infected with HIV. A preventive vaccine against HIV offers the best long-term hope to end this worldwide epidemic. Finding a safe and effective HIV vaccine that will protect people is a huge task. It cannot be done without the community's help.

- * The study is currently seeking 1350 men who have sex with men to participate in a vaccine trial.

- * One cannot become infected with HIV from the vaccines.

- * The study will take place in several cities in the United States.

Safety is a primary goal of the vaccine trial. This is a Phase II study, designed to yield limited information on the effectiveness of the vaccine. The research vaccines have been found to be safe in animals and hundreds of humans in previous trials. One of the vaccines is made from an inactivated cold virus known as an adenovirus. The vaccines do NOT contain the HIV virus, and CANNOT cause HIV infection.

'Don't Ask, Don't Tell'

Reported on Gaypolitics.com: Military recruiters have been told by the Pentagon that they must accept applicants who identify as gay or lesbian while a federal court judge's ruling suspending the "Don't ask, don't tell" policy is appealed, according to the Associated Press.

Still, recruiters are also instructed to tell applicants that the moratorium on the policy could be lifted at any moment. Federal attorneys are working to stay the judge's order lifting the ban on openly gay troops.

Salon.com reported that U.S. District Court Judge Virginia Philips declared the military's ban on openly gay service members unconstitutional in September, and she ordered a stop to the ban last week. Any minute now, she's expected to deny the government's request for a temporary stay of her injunction pending their appeal of her ruling.

Barack Obama wants "don't ask, don't tell" repealed legislatively. His Justice Department is charged with enforcing and defending the laws passed by Congress. So DOJ politely asked Judge Phillips to lift her order for the military policy to be immediately ended at the same time as Obama's Pentagon halted dismissals under the policy. It is a strategy that pleases no one, and Phillips was not convinced by the Justice Department's argument that ending the policy would cause "irreparable harm" to the armed forces.

"For those of us who work in education policy our focus is making the education case for these bills," said Eliza Byard, executive director of the Gay, Lesbian and Straight Education Network, known as GLSEN.

"And unfortunately we're doing that now in a context where recent tragedies have made the cost of not acting absolutely clear to everyone," Byard said.

She was referring to the September suicides of four gay youths ranging in age from 11 to 18 that authorities and family members said followed unrelenting bullying and harassment of three of the teens by their middle school or high school classmates.

The fourth youth, 18-year-old Tyler Clementi of New Jersey, jumped to his death from the George Washington Bridge.

Clementi, a freshman at Rutgers University, apparently became distraught when his roommate planted a video camera in his dorm room without his knowledge that captured him in a sexual encounter with another male. The roommate broadcast the encounter live over the Internet.

The Safe Schools Improvement Act, which was introduced in the House in May 2009 and in the Senate in August of this year, would require school districts receiving federal funds to adopt policies prohibiting bullying and harassment.

Someone once sent me a card remarking on how fall is the time of the year when strange looking people come knocking on your door. There's the trick-or-treaters of course and then there's something even more scary, the politicians.

We are facing what are called mid-term elections because they are taking place in a non-presidential election year. Yet it is the President that seems to be a huge factor in the current races, both in state races and federal ones. President Obama, still suffering under the mess that was left by George W. Bush, has dropped in popularity among his previous supporters for not taking stronger stands on his own policies. The Obama administration for example asked a federal appeals court to suspend the ruling that overturned the military's "don't ask, don't tell" policy on gays even though Obama claims to be against the policy. There are those who saw him as a great harbinger of hope but it has not turned out quite the way we hoped.

State races for federal office are being fought along the lines of how much support the candidate has for Obama (or Nancy Pelosi's) policies. Bill White, former Mayor of Houston, has been accused of a number of things by opponent Governor Rick Perry, including having participated in "Obama style spending". White was a hero of the Hurricane Ka-

O'Donnell, the GOP nominee for Senate in Delaware, was surprised to learn the Constitution had an amendment that prohibited the government from establishing a national religion.

While many of us are equally frustrated that not everything is the way we would prefer, we don't tend to restrict individual liberties or rights in our political activities. These folks seek to do just that. They are anti-gay and anti-choice. The movement's primary concerns, they claim, include but are not limited to, cutting back the size of government; lowering taxes; reducing wasteful spending; reducing the national debt and federal budget deficit; and adhering to the United States Constitution. Many of the movement's members also speak out on a wide variety of other issues such as illegal immigration. Most of us are concerned about those matters as well. The difference is in the approach we would take in addressing those issues.

The "adhering to the Constitution" means their interpretation of the document and there in lies the danger. They are worried about the deficit and admonish Obama for it when it was created during the eight years of George W. Bush and a Republican controlled Congress.

Yes, I am terrified of the direction this country may go if these Tea Party and other right-wing Republicans are in the majority of offices. They may not be the majority but their supporters are motivated to vote and that could win them the seats.

Bill White, former Mayor of Houston, has been accused of a number of things by opponent Governor Rick Perry, including having participated in "Obama style spending". White was a hero of the Hurricane Katrina and Rita disasters providing strong leadership when it was most needed, yet Perry accuses him of having profited from the crisis. There is no truth to this but that does not stop the mud-slinging ads. Perry refuses to debate White and with good reason: he knows he could not hold his own against White.

If Tea Party candidates win a bunch of races in November, will you ...

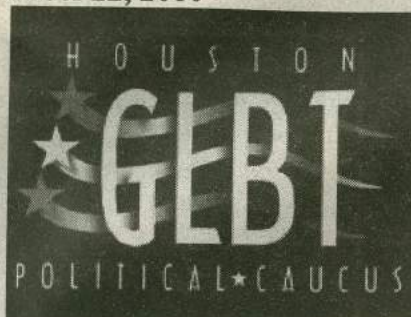
Be happy, finally, Washington will have politicians that represent the people? 5%

History at a Glance

The Gulf Coast Archive and Museum of History takes you to the very center of The Montrose: The Intersection of Montrose and Westheimer

Date: July 13, 1991

The Event: Ground zero – hate crime demonstration

The intersection of Montrose Blvd and Westheimer is considered the heart of The Montrose. In 1991 this was the place of a powerful demonstration. The community spoke and the world listened.

Nine days prior to this event, July 4, 1991, The Montrose had witnessed one of the most horrible attacks anyone could imagine. Paul Broussard, a 27 year-old Houston area banker was beaten and stabbed to death in a gay-bashing, just outside a Houston nightclub, by ten teenaged boys. Their names: Jaime Aguirre, Javier Aguirre, Derrick Attard, Jon Buice, Chance Paul Dillon, Rafael Gonzales, Gayland Randle, Leandro Ramirez, Brian Spake, and Jeffrey Valentine. They had driven to The Montrose from The Woodlands area, to "beat up some queers," in the testimony of one of the convicted teens. Paul Broussard and two friends were walking home just after 2:00 AM. When the attack began his two friends escaped down a busy street but Paul was cornered and beaten with a nail studded 2X4 and stabbed with a knife. He died just 8 hours later at St. Joseph's

Randle, Leandro Ramirez, Brian Spake, and Jeffrey Valentine. They had driven to The Montrose from The Woodlands area, to "beat up some queers," in the testimony of one of the convicted teens. Paul Broussard and two friends were walking home just after 2:00 AM. When the attack began his two friends escaped down a busy street but Paul was cornered and beaten with a nail studded 2X4 and stabbed with a knife. He died just 8 hours later at St. Joseph's Hospital.

The Houston news media did not initially report the murder as a hate crime. Queer Nation Houston began to organize public protests. Paul's mother, Nancy Rodriguez, also participated. More than 2000 demonstrators wound through the streets of The Montrose. People were angry! This was a hate crime! It was NOT OK to bash gays or anyone else for that matter.

The demonstration took over the intersection of Montrose Blvd. and Westheimer. This was ground zero. All of the pain, insults, threats, assaults, name calling, rapes and murders were remembered. The community was speaking as one. Hate crimes must be recognized and prosecuted. During this hour-long demonstration the mounted police retreated and watched from a block away. They were hoping to avoid a riot.

The brutal attack on Paul Broussard led to important changes in the Houston Police Department. The Houston Police Department's Hate Crime program was enhanced by Mayor Lee P. Brown and Chief of Police C.O. Bradford with the appointment of a Hate Crime Coordinator and the announcement of the Houston Police Department's Hate

A Testament

Comments made at the Montrose Counseling Center's The Secret is Out Program. Clients and others talked about the importance of the programs offered at MCC.

When I was younger, I had grand ambitions to stamp out prejudice where ever I found it and in some way elevate the human condition. You're allowed to think like that when you're a kid. But as I grew up, I realized that I may not have the power to create immediate change for a large group of people, but I can help improve the lives of one or a few.

Several years ago, I met someone who was in crisis. He was on the verge of losing everything he had and returning to a life of living on the streets and surviving day to day by what he called survival sex. This had been a pattern in his life for some time. His only pleasures in life were drugs and alcohol.

During a particularly difficult time in his life, he got up from his living room where we were both sitting and went back to his bedroom. He had been crying but then suddenly stopped. I went back to check on him, and he was hanging in his closet with his belt tied around his neck. Fortunately, I was there and was able to continue to be there for him.

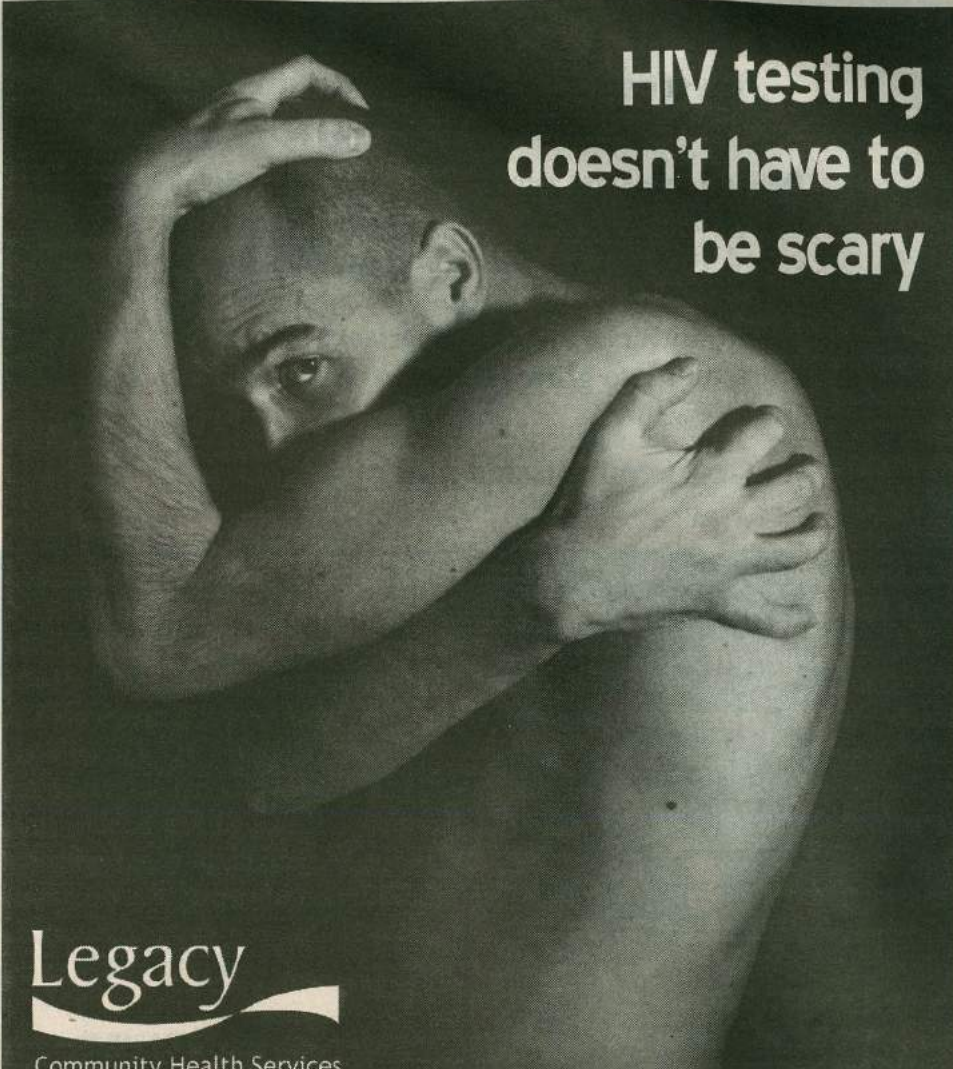
After many starts and stops, he was put on a medication regiment from MHMRA and sought substance abuse counseling here at MCC. We have

build support structures- a place where kids don't have to be alone. It is a safe place where kids can be who they are without worrying about being called a faggot, beaten up, or harassed to the point of misery. Since 1987, if these things were happening to you, then you had a place to go to get through it.

Over the last ten years that I have been with HATCH, I have seen subtle change in our society and how LGBTQ youth are treated and accepted. The age of those self-identifying as GLBT is getting younger. Young people, as a whole are more accepting of GLBT people. We have had HATCH youth go back to their schools and start Gay/Straight alliances. We have had HATCH youth age out and become community leaders here in Houston. A current HATCH youth just won a national leadership award for what she as done on behalf of GLBT issues. Openly gay youth can be elected student body president of their high school and college campuses.

However, there are still pockets of despair, misery, and suffering. Even when the majority is accepting, a few or a one can fill a person with hopelessness. We have had HATCH youth kicked out of their homes by their mother and father because they were gay or transgendered. We have had HATCH youth excommunicated from their church because they are gay. I truly believe that HATCH has saved many lives over the years.

He is on medication and is drug and alcohol free. This didn't happen overnight. It took him many tries, but I stood by him. I helped in anyway I could. Where I couldn't help, I found resources like MCC that could. I decided that I would do my damndest to improve the life of one. That, I could do.

My work and time I spend volunteering at MCC allows me to touch the lives of so many more. By connecting, volunteering, and financially supporting organizations like MCC, I can join with others and be a part of changing lives. MCC is one of the reasons my friend is alive and doing well today. I have been given an opportunity to be a part of improving the mental health and the human condition of those that are helped by MCC.

I found my way to MCC through my work with HATCH, which I have been involved with for over 10 years. When people used to ask me what I did for a living, I used to tell them that I was a HATCH facilitator and I work for a recruiting firm to pay the bills. HATCH is an affirming, safe place for teens to

spair, misery, and suffering. Even when the majority is accepting, a few or a one can fill a person with hopelessness. We have had HATCH youth kicked out of their homes by their mother and father because they were gay or transgendered. We have had HATCH youth excommunicated from their church because they are gay. I truly believe that HATCH has saved many lives over the years.

As a nation, we have lost 6 kids that we know of in the last several weeks to suicide due to bullying and harassment because they were gay or perceived to be gay: Raymond Chase-19, Tyler Cementi-18, Justin Aaber-15, Billy Lucas-15, Seth Walsh-13, Asher Brown-13. These kids should not have had to endure the form of harassment and character assassination that ultimately led to them taking their lives. GLBT youth are more vulnerable to the tragic consequences of bullying than most. In some cases they are afraid of being further isolated from their own family because of their sexuality. In the face of all this, we still have Lawmakers, Administrators and Professionals who refuse to acknowledge the existence and need for protection of LGBTQ youth in schools.

So, over time I have learned that, given time and perseverance, even small changes can lead to bigger changes in society. One of the simplest and most powerful actions we can each take is by living as openly gay and lesbian people so that no one can say they do not know a GLBT person. People are allowed to demonize those they don't know. If people know you to be a good, honest person who happens to be gay, it will make it harder for them to dislike or hate someone just because of their sexuality. Heterosexual friends and allies can also

The administration will now probably ask the Ninth Circuit Court of Appeals for a temporary stay. Again, Obama's preference for results to be achieved only through the "correct" process is killing him politically with his supporters and gaining him nothing from his opponents.

Alex Pareene wrote on Salon.com that, "If Obama actually thinks 'don't ask, don't tell' is a bad policy that should be overturned, he was just handed a gift -- a way to get rid of the policy without issuing an executive order or attempting to corral a lame duck congress. But he seems to worship the 'correct' process so much that he's willing to delay, or doom, the desired result."

U.S. District Court Judge Virginia A. Phillip, who last month struck down the policy, imposed an injunction ordering federal officials not to enforce the controversial policy on gays in the military. The federal government has 60 days to appeal, but Justice Department attorneys have not said whether they will.

"Defendants United States of America and the Secretary of Defense immediately to suspend and discontinue any investigation, or discharge, separation, or other proceeding, that may have been commenced under the 'Don't Ask, Don't Tell' Act, or pursuant to its implementing regulations, on or prior to the date of this Judgment".

Phillips said the policy banning gays did not preserve military readiness and that evidence shows that the policy in fact had a "direct and deleterious effect" on the military. She also found that DADT violated the 1st Amendment.

The policies must apply to bullying and harassment targeting people on the basis of sexual orientation and gender identity as well as other categories such as race, religion, gender and ethnicity.

Rep. Linda Sanchez (D-Calif.) introduced the bill in the House, where 125 members signed on as co-sponsors. Six of the 125 are Republicans. Sen. Robert Casey (D-Pa.) introduced the bill in the Senate, where 12 senators — 11 Democrats and one independent — signed on as co-sponsors.

In January of this year, Rep. Jared Polis (D-Colo.), who is gay, introduced into the House the Student Non-Discrimination Act. The bill would prohibit sexual orientation or gender identity related discrimination against students in public schools that receive federal funding.

"For the purpose of this act, discrimination includes, but is not limited to, harassment of a student on the basis of actual or perceived sexual orientation or gender identity of such student or of a person with whom the student associates or has associated," the bill states.

The bill also allows an "aggrieved individual" to take legal action in a judicial proceeding to seek enforcement of the bill's provisions barring sexual orientation or gender identity discrimination. It says the party taking legal action could be awarded compensatory damages and reimbursement of court costs for filing such an action.

ly address discrimination on the basis of race, color, sex, religion, disability or national origin, they do not explicitly include sexual orientation or gender identity and, as a result, LGBT students and parents have often had limited legal recourse for this kind of discrimination," he said.

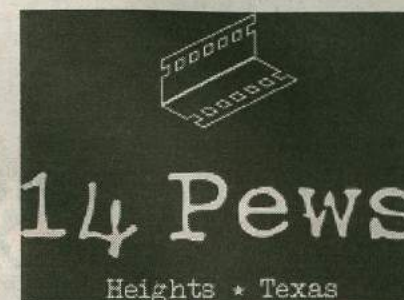
"The Student Non-Discrimination Act establishes a comprehensive federal prohibition of discrimination in public schools based on actual or perceived sexual orientation or gender identity and provides victims with meaningful and effective remedies, modeled after Title IX," he said.

Lautenberg announced last week that he plans to introduce an anti-bullying bill covering colleges and universities when Congress returns from its recess in November. He made the announcement on the Rutgers University campus in New Brunswick, N.J., during a forum called to discuss issues surrounding the suicide of Clementi.

He said his bill would require colleges and universities receiving federal funds to adopt a code of conduct that prohibits harassment and bullying. He said the bill would also call on colleges and universities to put in place procedures for addressing complaints about harassment and bullying and would provide federal grants to fund college programs aimed at preventing harassment and bullying.

Byard of GLSEN said studies show that LGBT students enrolled in schools that have adopted anti-bully and harassment policies are less likely to encounter bul-

Sadly, there are likely this many deaths every week, but the media and the general populace are just starting to realize the depth of this public health and social justice issue."

The case was filed by the Log Cabin Republicans, the largest political organization for gays in the GOP, in 2004. During the trial, Justice Department attorney Paul G. The sole evidence presented by the Justice Department was the legislative history of the ban, which government lawyers argued showed that the policy was properly adopted by Congress through a deliberative and reasoned political process. No witnesses were called.

Conversely, attorneys for the Log Cabin Republicans called to the stand several decorated military officers discharged for their sexual orientation, including Air Force Maj. Michael Almy. Almy, deployed three times to Iraq, said his commanding officer attempted to force him to admit he was a homosexual after another service member, without permission, searched Almy's private e-mail and found a message discussing homosexual conduct. After fighting his dismissal for 16 months, Almy agreed to accept an honorable discharge.

actual or perceived sexual orientation or gender identity of such student or of a person with whom the student associates or has associated," the bill states.

The bill also allows an "aggrieved individual" to take legal action in a judicial proceeding to seek enforcement of the bill's provisions barring sexual orientation or gender identity discrimination. It says the party taking legal action could be awarded compensatory damages and reimbursement of court costs for filing such an action.

In May, Sen. Al Franken (D-Minn.) introduced an identical version of the bill in the Senate. Twenty-five senators, 24 Democrats and one independent, signed on as co-sponsors. The House version of the bill pulled in 125 co-sponsors, 123 Democrats and two Republicans.

Both the Safe Schools Improvement Act and the Student Non-Discrimination Act have been referred to the House and Senate education committees.

Lara Cottingham, a spokesperson for Polis, said the congressman was hopeful that a legislative hearing on the Student Non-Discrimination Act would be held next year. She said no date has been set.

"Every day, students who are, or are perceived to be, lesbian, gay, bisexual, or transgender (LGBT) are subjected to pervasive discrimination, including harassment, bullying, intimidation and violence, which is harmful to both students and our education system," Polis said in a statement at the time he introduced the bill.

"While civil rights protections express-

He said his bill would require colleges and universities receiving federal funds to adopt a code of conduct that prohibits harassment and bullying. He said the bill would also call on colleges and universities to put in place procedures for addressing complaints about harassment and bullying and would provide federal grants to fund college programs aimed at preventing harassment and bullying.

Byard of GLSEN said studies show that LGBT students enrolled in schools that have adopted anti-bully and harassment policies are less likely to encounter bullying.

"LGBT students in a school with such a policy in place are less likely to be victimized themselves, are more likely to report that faculty actually intervened when things happen, and are themselves more likely to be in a better place in terms of their own well being and their future educational aspirations," she said.

Most, but not all, D.C. area senators and House members have signed on as co-sponsors for the Student Non-Discrimination Act. Co-sponsors include Congressional Del. Eleanor Holmes Norton (D-D.C.), Reps. Chris Van Hollen (D-Md.) and Jim Moran (D-Va.), Sens. Barbara Mikulski (D-Md.), and Sen. Benjamin Cardin (D-Md.).

Reps. Donna Edwards (D-Md.) and Frank Wolf (D-Va.), and Sens. Mark Warner (D-Va.) and Jim Webb (D-Va.) have not signed on as co-sponsors of the bill.

Cardin, Moran and Norton are the only D.C. area members of Congress that became co-sponsors of the Safe Schools Improvement Act.

Peter Pan: The Boy Who Never Grew Up (at The Alley) is aimed directly at thinking adults. It's not a play for children.

It's a play about children for adults. However, since it also makes the point that adults often act like children, it's also a play about adults for adults.

Now take John (Adam Van Wagoner), for instance, the older of Wendy Darling's two brothers. He is the one who takes after his father the most. Compared to him, his little brother Michael (Emily Neves) is almost femme -- a bit sensitive for his day and time -- but much more caring. Pity he has to grow up. "*All children grow up, except one -- Peter Pan.*"

Peter has spent some time explaining to Wendy that every time a child says "I don't believe in fairies," a fairy falls down dead. John comes in and when Wendy tells him they are about to meet a fairie, the very first thing John says is "I don't believe in fairies." And you hear a little clunk from afar.

Jill Brenner is a pretty typical young girl. She has a best friend named Tracy, two OK parents, and an annoying little brother. This year she is a little disturbed because her best friend won't be in class with her but other than that things are OK, until it comes time to give book reports.

One of the girls in Jill's class is named Linda Fischer and her report is on whaling. Throughout the report, Linda, who is somewhat chunky, continually talks about Blubber - prompting one of the most popular girls in the class to pass around a note saying that "Blubber" would be a great nickname for Linda.

From there things quickly spiral out of control as the entire class, led by popular girls Wendy and Caroline, proceed to make Linda's life hell. They torment her to tears regularly on the playground by making up horrible jump rope rhymes. They torment her in the lunchroom by mocking everything she eats, they torment her when they happen to come across her outside of class (Jill is so inspired by the bullying she invents an anti-blubber Halloween costume), and even in class (poking, throwing spitballs, passing rude notes) when the teacher is not paying attention (which seems to be most of the time).

At first, Jill goes along with the kids in her class because she thinks it's fun and

that all these years later, Blume's graphic depiction of bullies and bullying still rings true.

The book, just like most bullying, does not have a happy ending. While Jill is eventually able to fight back against the bullies and save herself, the result is that another target is chosen. Linda Fischer, meanwhile, ends up as what she was before being bullied, an odd loner that no one really likes or talks to.

In her new introduction, Blume talks about how the idea for the book came to her when her daughter came home from school talking about how a girl in her class was being bullied. Blume's daughter was uncomfortable with the bullying but didn't know how to react or respond to it. Blume wrote the book to empower her daughter and others, and to show them that they are not alone.

Sadly, 36 years later, children and still being bullied into killing themselves; and adults appear to be just as clueless as the hapless teacher in in this book.

Cooking Capers with Dr. Dave

Living in Texas, I stopped and realized how fortunate we are to have the Hispanic culture here. Yet, even as I ate chips and salsa at one of my favorite Mexican restaurants the other day, it dawned on me I have not shared some of my Mexican recipes with you. A good friend of mine, Myra, an established chef in numerous food styles, taught me these. I hope you like them.

APPETIZER

Aguacate Relleno con Escalope
(Avocado Stuffed with Scallops)

12 oz shucked (opened) scallops
1/3 cup fresh lime juice
1 tablespoon minced fresh oregano (not dried)
1 tablespoon minced fresh cilantro
2/3 cup olive oil
salt and freshly ground pepper
3 large avocados, ripe but slightly firm
minced chile serrano (optional)

Place the scallops in a bowl and add the lime juice, oregano, cilantro and oil. Season with salt and pepper and let stand for 20 minutes or until opaque. This process "cooks" the seafood. Cut the avocado in half, remove the pit and spoon out balls of the pulp, reserving the avocado shells. Mix the avocado balls with the scallops and spoon the mixture back into the avocado shells. If desired, sprinkle minced chile serrano on top. Ummmm....good!

SOUP

Sopa de Queso (Cheese Soup)

1 poblano pepper
1 green bell pepper
3 tablespoons butter
1/2 cup chopped onion
5 cups chicken stock

6 fillets of firm-fleshed white fish such as snapper or sea bass about 5 oz each
salt and freshly ground pepper
2 tablespoons Worcestershire sauce
2 1/2 cups mayonnaise
1/4 cup dry white wine
1 tablespoon minced dried cilantro
1 teaspoon dried tarragon
2 tablespoons Pernod
1 tablespoon lime juice
1 large red onion, thickly sliced
3 tomatoes, peeled and thickly sliced
12 pitted green olives

Rinse fish and pat dry. Season with salt, pepper, and 1 tablespoon Worcestershire sauce. Cover and refrigerate for at least 1 hour. In a bowl, combine the mayonnaise, wine, cilantro, tarragon, Pernod, lime juice, and the remaining tablespoon of Worcestershire sauce. Preheat oven to 375 degrees. Cut 6 sheets of aluminum foil which are approximately 8 by 10 inches. Coat each sheet of foil with a tablespoon of the mayonnaise mixture. Place a fish fillet on the foil and cover lightly with more of the mayonnaise mixture. Top with 2 slices of onion, 2 slices of tomato, and 2 olives. Fold the foil to form an envelope and roll the sides so that the juices won't seep out. Place the foil packets in a baking pan and bake for 10 to 20 minutes depending on the thickness of the fillets. Good stuff!

Believing in a Gay Spirit

Many of us watched with fear and hope the saga of the miners trapped hundreds of feet below ground level in Chilean mines.

Some of us lost hope. Some of us remained fearful. Some of us clung desperately to our hope that the miners would be rescued. We hoped that they would be rescued from the darkness of the mines.

Isn't it the same for many of us in our daily lives?

Many gay, lesbian, bisexual, and transgender youth hope that somehow they will be rescued from oppressive lives at school and often even at home.

Many GLBT adults hope for rescue from oppressive religious leaders while clinging desperately to the faith that continues to transform our lives.

As a wonderful seminary classmate reminded me recently, "We all need to be rescued at some point in our lives."

But she also added that, "We may, too, be asked to rescue."

How many of us would be willing to be crammed into a capsule so narrow we had to hunch our shoulders and be lowered over 2,000 feet down a shaft to a place of desperation, fear, and isolation?

The rescuers who were lowered to that dark place also found hope. They also

There were moving testimonies from parents and teachers about successful and failed attempts to combat bullying on school campuses. There were impressive presentations from several local school districts about their anti-bullying programs. Some parents testified that those programs don't always work well because teachers are afraid to intervene.

There was a clarion call issued at the hearing for legislation that will not only provide educators the security and support they need in order to successfully combat bullying, but a call for legislation that would mandate that educators address bullying on our school campuses.

When the Coming Out Support Group of the Houston GLBT Community Center (www.houstonglbtcommunitycenter.org) convenes every first and third Monday, we hear stories from teachers who are afraid to address bullying because they know they will be targeted by colleagues and supervisors if they do so.

And they find hope in our gatherings. They find solidarity. That's how we can offer hope. We must foster the creation of gay-straight alliances in each and every high school. We must have anti-bullying programs in every school. We must offer places where GLBT youth can find that solidarity, that hope that we all need in our lives.

SOUP

Sopa de Queso (Cheese Soup)

1 poblano pepper
1 green bell pepper
3 tablespoons butter
1/2 cup chopped onion
5 cups chicken stock
2 tablespoons all-purpose flour
2 tablespoons cornstarch
3/4 cup water
4 cups evaporated milk
1 teaspoon salt
1 teaspoon freshly ground black pepper
4 oz. queso Chihuahua (or Monterey Jack) finely chopped
1 cup chopped tomato

Remove the stems, seeds and membranes from the chile and bell peppers and cut into a small dice. Melt 1 tablespoon of the butter in a skillet, add the onion and saute for about 2 minutes or until transparent. Add the chile and bell pepper and cook for 3 additional minutes; set aside. Bring the stock to a boil in a large saucepan. Whisk in the flour and cornstarch in the 3/4 cup of water, add to the stock and stir constantly for 2 minutes. Add the milk and lower the heat. When it comes to a boil, add the peppers and cook over low heat for 5 minutes. Add the salt and pepper and cook 2 minutes more. Add the remaining tablespoons of butter and set aside. Before serving, heat the soup and place 2 tablespoons of cheese and 2 tablespoons of tomato in the bottom of each bowl. Enjoy!

(Fish Fillets Baked in Foil with Tomatoes, Cilantro, and Red Onions)

Dressing for Artichokes

4 hard-boiled eggs, finely chopped
1 cup finely chopped onion
3/4 cup mayonnaise
1 1/2 tablespoons Dijon mustard
2 teaspoons red wine vinegar
2 teaspoons olive oil
1/3 cup minced parsley
1/2 teaspoon salt
1/4 teaspoon white pepper

Cut the stems of the artichokes flush with the bottoms and cut off the thorn-like tips of the leaves. Place about 3 quarts of water in a large pot with the salt, bay leaves and baking soda. Bring to a boil and add the artichokes; cover and cook for 20 minutes. Drain. With a small knife, pull out the fuzzy choke in the center of each artichoke and discard. Place the artichokes upside down on a platter and chill. To make the dressing, combine the eggs, onion, mayonnaise, mustard, vinegar, oil, parsley with salt and pepper. If the mixture is too thick, thin with water to the desired consistency. Chill. Immediately before serving, spoon the dressing into the center of each artichoke. These are great!

There is a HUGE question right now for so many of us not only in regard to GLBT youth, but also struggling GLBT adults, and all who are perceived to be different:

How can we bring hope to these folks? How can we tell them in loud, clear voices that "IT GETS BETTER!" in ways that will transform their lives and save them from despair?

Congresswoman Sheila Jackson Lee took a step in that direction Monday evening when she convened a local, state, and federal hearing at Houston City Hall to address bullying of youth.

are afraid to address bullying because they know they will be targeted by colleagues and supervisors if they do so.

And they find hope in our gatherings. They find solidarity. That's how we can offer hope. We must foster the creation of gay-straight alliances in each and every high school. We must have anti-bullying programs in every school. We must offer places where GLBT youth can find that solidarity, that hope that we all need in our lives.

Jesus Christ taught that the most important things for us to do in life are to love God and to love everyone else.

We have to ensure that children and adults learn how to love themselves so that they can then in turn love others. They have to know that, "IT GETS BETTER!"

We have to have more public speeches like the one given at a Fort Worth City Council meeting by Councilmember Joel Burns (http://www.youtube.com/watch?v=1YHglV8_h9E) about how "IT GETS BETTER!"

His emotional, hopeful words will truly save lives. May an avalanche of people come forward to do the same.

Now is the time to put our feet to the pavement and join the groups like the Houston GLBT Community Center, the Gay, Lesbian, Straight Education Network (GLSEN), the Human Rights Campaign, Equality Texas, and others that are on the ground working to combat and end bullying against all people who are perceived as different.
