



Urban Plunge

Approximately 75 students came to Kansas City the weekend of February 14-16 to become involved with (rather than just to look at) "the urban, erotic, and racial aspects" of life. The "Urban Plunge" was sponsored by the University Christian Movement at the University of Kansas.

Homosexuality was chosen as one example of the erotic, perhaps because most people know so little about it. After visiting night spots catering to heterosexuals and then visiting several gay establishments, "Plungers" commented on the friendlier atmosphere of the gay spots and on the fact that it seemed to be the people in the gay places who were really enjoying themselves.

Race, violence, and dissent were other subjects touched on during the Urban Plunge. Speakers were the Rev. Sethard Beverly, pastor of the Church of God, Kansas City, Ks.; the Rev. L. Vann Anderson, Methodist Metropolitan Planning Commission; and the Rev. Phil Lawson, United Methodist Inner City Parish, Kansas City, Mo.

A Sunday afternoon worship service at Country Club United Methodist Church was a highlight of the Plunge. The Rev. Jim Donaldson suggested in sermon that the best part of the service might be for the people at the front of the church (mostly Plungers and other young people) and the people in back (mostly local people, many of them members of the church) to get together. Anyone who saw the WDAF-TV news broadcast showing worshippers dancing to the music of the Mystic Number National Bank knows that the people did get together.

However, those who saw only the broadcast should realize that the dancing was only one part of a meaningful, worshipful service. It was important because it did knit together, at least momentarily, the two groups in the afternoon congregation. The liturgy led by KU campus minister Morni Leoni, the anthems "He Was a Friend of Mine" and "Brother, Where are You?" sung by Jinny, and Jim Donaldson's sermon were important elements in the service.

"The Urban Plunge," commented Phoenix member Richard Barber, "gave me more incentive to be involved with all aspects of life, to help improve the understanding of the homophile world we live in (and) to point out to others their importance in life . . .






Out Of Town

Undefined Crime

Las Vegas: An "infamous crime against nature" is the crime of which Richard Powell was found guilty in Las Vegas in February, 1967. The elements of the crime were considered "so repugnant to the framers of the law," as a Tangents Newssheet puts it, "that they left the acts that constitute the crime undefined."

Powell is fighting the conviction on the grounds that "it is unconstitutional to try a person for a crime for which a criteria (sic) has not been set out in the statute."

The case is presently being appealed in the Ninth Circuit Court. Financial aid is needed, Tangents reports, and may be sent to Tangents, 3473 1/2 Cahuenga Blvd, Hollywood CA 90028, and should be earmarked "Legal Defense Fund."

Dutch Urge Tolerance

Amsterdam: City of canals, bicycles, and narrow brick houses, but also city of priests in business suits, "provos," and acknowledged homosexuals.

The provos, the original flower people, were "killed" with understanding. Clashes between police and the "strangely dressed youths" accomplished nothing, according to an article by John L. Hess copyright by the New York Times Service, but authorities discovered that the provos disbanded and disappeared into society when they were confronted with tolerance and acceptance.

And now the acceptance is being directed toward the homosexuals. Church and social agencies are working to integrate homosexuals into Dutc. society by attempting to get other people to accept them and by providing counselling for the homosexuals themselves, including "a sort of marriage counselling."

What is present military policy on homosexuals? Anyone who is convicted of a homosexual act or who "exhibits, professes, or admits to homosexual tendencies, or associates with persons known to him to be homosexual" may be discharged from the services. Men or women confessing to homosexual relations while in the service are liable to undesirable discharges which put them at a serious disadvantage when looking for employment.

How do the services find out about homosexual activity? From civilian police, through anonymous phone calls or letters, through official service investigations. The latter are often full-fledged witch hunts that incriminate large numbers of servicemen. The investigators obtain a few names to begin with and then persuade those questioned to name others. In one notable case a few years ago, about 300 seamen of different ranks were removed from an aircraft carrier with a complement of about 3000 men.

How are investigations carried out? Agents of the Office of Special Investigations, the Office of Naval Intelligence, or the Criminal Investigations Division search personal possessions for incriminating letters, pictures, magazines, advertisements, etc. They may also check on names in address books. These professional investigators do an outstanding job of extracting information from accused men, ob-

taining their co-operation and placing them at a disadvantage. Though they may tell the accused of his right to remain silent or of his right to a lawyer, they do this in such a way as to make him feel guilty if he exercises these rights.

What specific techniques are used to obtain information? The investigators suggest: "A lawyer isn't going to do you any good."

"This is a little matter you and I can straighten out between ourselves right here and now."

"Why don't you just tell us what happened and get it off your chest?"

"Telling us about yourself and what you have done will speed up the process of getting out; otherwise you will be around a long time."

"Homosexuals are people too; they can't help being the way they are; there's nothing to be ashamed of; society's hostility isn't justified; you are a pretty nice guy: once you're out of the service everything will be O. K."

"We realize you are sick; come clean with us and we'll see that you get medical help."

"We have all the essential data; all we need to do is just fill in a

couple of details."

"If you confess, everything will be nice and quiet; no one needs to know what has happened." (In fact, however, parents of a man under twenty-one are often notified that their son has been discharged for homosexuality.)

"We've got the goods on you and if you don't co-operate we'll throw the book at you."

"If you don't confess, we'll go to your family, friends, and associates; then everyone will know you are a queer."

"After you get out you can have your discharge reviewed; and you'll stand a good chance of having it changed." (This is not true.)

The investigators also often employ the "good guy-bad guy" technique in which one man acts rough and tough and the other one sympathizes and tries to "help" the victim.

What can you do if an investigation begins on your base? If you want to protect yourself or some other serviceman who is being investigated, get in touch with a homosexual civil rights group in urged not to keep such names and addresses in their possession - Ed.)

What should you do if you are questioned? REMAIN SILENT and ASK FOR A LAWYER. You have a legal right to refuse to answer any questions. You may ask for a military lawyer to defend you or for a civilian lawyer. However, not any civilian lawyer will do. He should be familiar with military law and be willing and able to handle your case effectively.

Probably over 90% of men convict themselves through confessions when the authorities do not have sufficient evidence for a case. There is no need for you to do the prosecutor's work for him. Remember that the investigators do not have your best interests at heart.





The Principles of the Committee are:

- We will uphold and defend the Constitution of the Phoenix Society for Individual Freedom, Inc. and abide by its purposes and objectives.

- 3. Realizing that the goals of the Phoenix Society cannot be reached in a day, we will work toward meaningful objectives with patience, sound judgment, and thorough understanding of the problems we face.
- 4. We will oppose any attempts to turn Phoenix Society into an avantgarde, new left, militant type organization.
- 5. We will at all times remember the great responsibility we have to our people, so that none of our actions or utterances will in any way be an embarrassment or a hindrance in their private lives.

The real issue in the forthcoming Phoenix Society elections is not the political orientation of the various candidates. (The M. A. N. Party has been characterized as "avant-garde, new left militant" by its opponents.) The real issue is who is willing to do the work necessary to make the Phoenix Society an effective organization.

A well-written constitution is meaningless unless dedicated, energetic and imaginative people are present to turn its tenets into reality. The M. A. N. candidates have shown they are willing to work to put Phoenix principles into practice.

M. A. N. recognizes its responsibility toward the members of Phoenix, but it also realizes that the responsibility consists of more than protecting the anonymity and integrity of the Society's individual members and exercising foresight and discretion in working toward Phoenix goals. These principles we have always adhered to and will continue to apply to all our official activities.

Just as important as these responsibilities, however, is the responsibility for improving the overall lot of the homosexual in our society through a dynamic series of educational activities aimed at the general public.

At the risk of being divisive, we must offer the opinion that our opponents' professed objectives of "advancement of the homosexual... in a responsible orderly manner" have too often — not always, but too often — been exhibited in their past performances in Phoenix activities as lethargy and indecisiveness. Virtually every night of the week M. A. N.'s candidates can be found at 1333 Linwood, working on THE PHOENIX, answering phone calls, conducting seminars, writing and typing letters.

Where have most of our opponents been? At home? Being "orderly"?

Toleration is not something that an ignorant public confers on an abused minority as a reward for being "orderly". Sympathy and understanding will come only when that minority is willing to engage the public in a continuing, meaningful dialogue directed at erasing fears and prejudice. We feel that this incessant dialogue is something that we owe our fellow members of Phoenix. This is what holding office in Phoenix Society for Individual Freedom, Inc. means to us.


if you were awake.


If you were awake I would try to tell you how I love you. My words would fail. Words — man's pitiful descriptions of undescribable emotions.

When it comes to incriminating others, the chief difficulty is that America's homosexual community has not yet developed a sense of solidarity and of mutual responsibility.

But you should remember that about 40% of all servicemen have engaged in homosexual acts for which they might be discharged and that, according to the best statistics we have, about 10% of them are predominantly homosexual in their sexual orientation. For this reason alone, the policy of excluding homosexuals from the services is totally unenforceable. Moreover, if it could be effectively enforced, it would reduce the nation's military strength so drastically that it would have to be dropped.

What reasons do the services give for excluding homosexuals? It is frequently claimed that:

(a) Homosexuals are security risks because they are subject to

blackmail.

(b) Homosexuality is the manifestation of a severe personality defect.

(c) Homosexuals form cliques,

- (d) Homosexuals are criminal and immoral persons who contaminate others and discredit the service.
- (e) Homosexuals impair military morale and discipline.

However these arguments do not hold water, as a moment's reflection will show.

- (a) First, it is the service regulations themselves which create the major blackmail problem. Without them, unmarried homosexuals would be less vulnerable to blackmail on sexual grounds than married heterosexuals.
 - (b) The preponderant opinion

among biologists, anthropologists, sociologists, and clinical pyschologists is that homosexuality is not a sickness. Psychiatric opinion is divided on the subject, but the sickness theory is now strongly challenged as merely a modern rationalization of ancient moral and religious prejudices.

- (c) Any minority group Catholics, Masons, Jews, Negroes, Rotarians, etc. may form cliques. The thing to do is to break up the clique, not to exclude the minority from service.
- (d) The American Law Institute favors dropping the laws against homosexual relations between consenting adults in private. One state (Illinois) has already made this change. American religious groups are now beginning to support law reform and some are now seriously questioning the view that homosexual conduct is immoral.
- (e) Undoubtedly there are a few men who are upset by the presence of homosexuals just as others are upset by Negroes or Jews. But it is at least arguable that homosexuality (like heterosexuality) may on balance contribute positively to military morale. Finally, homosexuality is an offense against discipline only because military regulations make it one.

America's ten million homosexuals form one of the nation's largest minorities. To condemn this group to prison, to harass it through questionable police tactics, and to exclude it from public employment is foolish and inequitable.

As far as military performance goes, statistics show that over 98% of homosexuals serve without difficulties on the score of their sexual preferences. Many have served with distinction.

Present military policy is illadvised, unenforceable, unjust, and discriminatory, and should changed. Witch hunts should be stopped immediately, and anonymous or malicious accusations against servicemen or women ignored.

As in civilian life, laws against homosexual relations between consenting adults in private should be regarded as dead letters until they are repealed. Only in those rare instances where force or coercion is used should homosexual conduct be a matter of concern for military authorities.
